**APPLICATIONS ARE INVITED ONLINE FOR REGISTRATION & SANCTION OF  
PERMISSION TO RUN THE HOSTELS WITHIN THE PREMISES OR OUTSIDE THE  
PREMISES OF PRIVATE UNAIDED JUNIOR COLLEGES IN TELANGANA STATE FOR THE  
ACADEMIC YEAR 2018-19.**

Online applications are invited from the Managements of Private Unaided Junior Colleges in the Telangana State for registration & sanction of permission to run the hostels Within the Premises or Outside the Premises of Private Unaided Junior Colleges for the academic year 2018-19.

In the interest of the Students' Community and to avoid any Unforeseen Incidents in Hostels, the Telangana State Board of Intermediate Education has decided to register & grant permission; and regulate the hostels' functioning within the premises or outside the premises of Private Unaided Junior Colleges from the Academic Year, 2018-19.

The managements of Private Unaided Junior Colleges are informed that the Inspection Fee & Hostel Permission Fee are as follows:

1	GHMC / Municipal Corporations	80,000/-	1,00,000/-
2	Municipalities / Nagar Panchayats	60,000/-	80,000/-
3	Gram Panchayats (other than 1 and 2 above)	50,000/-	60,000/-

The Management should deposit the stipulated amount as mentioned below as Caution Money Deposit / Corpus Fund in a Nationalized Bank in the Joint Account of the Secretary / Correspondent of College Management Society running Hostels and the District Intermediate Education Officer / Nodal Officer of concerned District. The value of this varies with the number of hostellers as mentioned below:

Sl No	Strength of Students	Specifications of FDR
1	Up to 50 students	For I Yr-Rs 2.0 Lakh+ For II Yr- Rs. 2.0 Lakh = Rs.4.0 Lakh
2	51 to 200 students	For I Yr-Rs 4.0 Lakh+ For II Yr- Rs. 4.0 Lakh = Rs.8.0 Lakh
3	201 to 500 students	For I Yr-Rs 6.0 Lakh+ For II Yr- Rs.6.0 Lakh = Rs.12.0 Lakh
4	500 and above	For I Yr-Rs 8.0Lakh + For II Yr-Rs. 8.0 Lakh =Rs.16.0 Lakh

The managements are requested to see that No Objection Certificate to run the hostel issued by the concerned authority, Trade license issued by GHMC or local body, Food Safety Certificate issued by Competent Authority, Registered Lease Deed of the Hostel Building & Playground, Fire Safety Certificate, Sanitary Certificate and Structural Soundness Certificate are in force for the period for which they have requested for grant permission to run the hostel within the premises or outside the premises of Private Unaided Junior Colleges. The Fire Safety Certificate should be renewed periodically as per the norms of Fire Services Department. If the management fails to provide/upload the required specifications of accommodation in Hostel Building and the documents as per the Guidelines /Conditions/ Stipulations, those proposals will not be considered.

The managements are hereby requested to apply online for registration / sanction of permission to run the hostel within the premises or outside the premises of Private Unaided Junior Colleges, from the official website (<http://www.acad.tsbie.telangana.gov.in>) of Telangana State Board of Intermediate Education with effect from **05.04.2018**. The prescribed Registration & Inspection Fee should be paid through online payment only. **Offline (Manual) payments through DDs, Challanas and submission of Offline Form will be summarily rejected.**

After **20.04.2018**, the requests for sanction of permission to run the hostels within the premises or outside the premises of Private Unaided Junior Colleges will not be considered under any circumstances. Hence, the managements of Private Unaided Junior Colleges are requested to adhere to the Guidelines/Conditions laid down for grant of permission to run the hostels scrupulously, which are placed in the official website of TSBIE i.e. <http://www.acad.tsbie.telangana.gov.in>.

The last date for uploading applications along with necessary enclosures is **15.04.2018** without late fee. Further the time schedule is as follows.

Any proposals submitted directly in the head office will be summarily rejected.
