N.B.

- (4) Income for the purpose of Means Test is defined as under:-

 - (b) In the case of income from source liable to income tax, income computed (after deduction for rebateable items) for the purpose of assessment of income tax, as per Income Tax Rules for the year.
 - (c) In the case of income not liable to income tax, such as income from Agriculture, etc. the net income that is arrived at after deduction of expenditure incurred for earning that income.
