Sub: Intermediate Education – Central Sector Scheme of Scholarship for College & University Students for the year 2014-2015 – Intimation of **provisional** selection of candidate – Reg.

ORDER:

Master/Kum. with Roll. No..... who was declared as passed in “.....” Grade in group with totalmarks of aggregate with **Schp. ID No.** in the Intermediate Public Examination March, 2014 from college (Code No.)..... is **provisionally** selected for the award of Central Sector Scheme of Scholarship for College and University Students for the year 2014-2015 subject to the following conditions.

Eligibility for Provisional Selection of Scholarship:

- a) A student should get minimum of above 80th percentile of successful candidates in the relevant stream at +2 stage i.e., in IPE March, 2014. Regarding percentile system of calculation, it was clarified by the MHRD, New Delhi that ‘above the 80th percentile’ would mean that the top 20% students in a particular stream would be considered for award of the Scholarship.
- b) He/She should pursue regular bachelor degree course only (Students, who intend to pursue courses on correspondence or distance mode; Chartered Accountancy (CA)/ Diploma in Education, Nursing, Computers etc. **are not eligible**) from a recognized educational institution (admitted in 2014-15, 1st year) & put up 75% attendance. Further, the student should take admission in the same academic year i.e. 2014-15, without any gap in the academic year after passing Intermediate course, due to any reason.
- c) The candidate’s parental (Father & Mother)/Guardian’s / Husband’s (in case of married women) income shall not exceed Rs.6,00,000/- P.A. ending with March, 31st 2014.
- d) Applicant who is eligible for FAST - Financial Assistance to students of Telangana (sanctions by Govt. of Telangana) can also avail this Scholarship (CSSS) provided he / she should NOT avail ANY OTHER MERIT Scholarship sanctioned by the State / Central Govt. / or any other Govt. Agency.
- e) The Govt. of India has allotted 2,570 Scholarships to Telangana State, which are divided among Boys and Girls in the ratio of 1:1 and among science, commerce, humanities in the ratio of 3:2:1. As per the guidelines 2½ times of above number, the candidates are **provisionally** selected. However, **final selections** will be made based on the applications received and lists will be sent to MHRD, GOI, New Delhi, for sanction of Scholarships. After sanction orders are received from GOI, the final selection lists will be furnished to Degree Colleges and the information will be kept in BIE Website as well.
- f) The Scholarships for post Intermediate students are given on the basis of state wise merit lists. Reservations for various categories are as follows: SC 15%, ST 7.5 %, OBC 27%, and PH 3%. These applicants have to enclose copy of Caste/P.H. certificates issued by the competent authority.
- g) Applicant with full time employment is not eligible.
- h) The Scholarship will be paid from the month of admission in the college @ the following rates:
@ Rs.1,000/- P.M. for a maximum period of 10 months in an academic year for degree/ professional degree course and can be renewed for 2nd & 3rd year for Degree Course and 4th & 5th year of PG Course in the same stream, depending on promotion to next class, provided he/she secures 60% or more marks, with an attendance of at least 75%, with good behaviour in each year. He/She should apply for **renewal of Scholarship every year**, soon after announcement of results or within (15) days from the re-opening of Degree/Engineering Colleges. The **renewal application** may be down loaded from BIE Website www.bieap.gov.in (ii) and @ Rs.2,000/- P.M for 4th & 5th year for a maximum period of 10 months for professional degree /P.G. course. **For all professional courses, scholarship will be renewed till the graduation level of that course** subject to maximum of five years. (iii) The amount will be credited into the students’ bank account directly by the Central Govt. under DBT System. The student should furnish correct Bank account particulars with on-line facility for e-transfer of the amount as mentioned in Data Sheet at Sl.No.11. (iv) the **Principal of degree / professional degree college** has to fill the particulars of joining report and submit along with this application form.

- i) The students' are advised to ascertain from the Principal of the College, as to when his / her application is forwarded to BIE, TS, Hyd. is it within the due date or not. Likewise, the Principals are requested to put the same information in the Notice Board of the College.
- j) This is a Govt. of India Scheme and the guidelines received from time to time from them will be followed for sanction of scholarships and the Board of Intermediate Education is only the executing agency of the scheme. **The Board will not take any responsibility in this regard.**

INCOME CERTIFICATE:-

- A) The income affidavit should be signed by public registered notary/1st class magistrate / or Tahsildar concerned. In the case of employees, salary certificate should be enclosed together with the income affidavit.
- B) In the case of parents/guardian who draw salary, the D.A., CCA etc., shall not be included in determining the income. Deputation allowance, honorarium, special pay and bonus etc shall be treated as income. The defective and belated applications will not be considered and they will be rejected without any intimation.

Guidelines to the Principals are given below.

- A) The **Principal of Jr. College** is requested to handover this proceeding along with the application to the candidates concerned for compliance and necessary action as per the residential address of the candidates in the college records. **The Principal should not keep the application forms with him/her under any circumstances & it should be delivered to the candidates within 3 days from the date of receipt.** If the address is not available or his/her address is not known, it should be returned to this office.
- B) On receipt of these proceedings and filled in application form from the student, the **Principal of degree / professional degree college** is requested to verify whether the Roll. No. recorded in these proceedings and in the application is one and the same and he should be satisfied that the Roll No. mentioned in the application is in respect of the genuine candidate only. He is also requested to inform the candidate/parents that direct correspondence with the Secretary, Board of Intermediate Education, shall not be entertained. Further correspondence if any, may be routed through the proper channel only.

The filled in Data Sheet & Application Form should be sent **to the Professor, Central Sector Scheme of Scholarship for College and University Students (CSSS), Board of Intermediate Education, Telangana State, "Vidya Bhavan", Nampally, Hyderabad-500 001**, through the institution where the candidate is now studying U.G. Degree/Professional Degree Course along with their joining report, **a xerox copy of this proceedings**, income affidavit, other required attested copies of certificates etc. The **Principal of Degree/Professional Degree Courses** where the candidates are now studying has to forward all the applications of provisionally selected candidates **at a time** along with the list in the following pro-forma in **order of merit**, in order of **Science/Commerce/Humanities**, so as to reach this office **on or before 30-11-2014**. The applications received after the above due date will not be considered.
